HISTORY & PURPOSE

Within the nearly 17 million acres of forested

landscape in Pennsylvania lies the Upper Allegheny Plateau, a region recognized worldwide for its high-quality hardwoods. The Allegheny Hardwood Utilization Group, Inc (AHUG) was organized in 1984 for the purpose of promoting this exceptional natural resource asset, and for
